Terms of Reference for the post of Director General, KSU

Application/Nominations are hereby invited for the post of Director General of Kaushalya The Skill University formed under Labour, Skill Development and Employment Department, GoG vide Gujarat Act No. 22 of 2021.

Essential Qualification and Experience:

- The Director General shall be appointed from the field of technology, Science, Public Administration, Skill Development or Management, and shall not have completed more than sixty years of age as on the last date of application.
- He/she shall be a person of high repute in academics/Skill Development and have significant credentials to support the same.
- The person to be appointed as a Director General should be a
 - distinguished academician, with a minimum of ten years' of experience as Professor in a University **OR**
 - ten years' of experience at an equivalent level in a reputed research and / or academic administrative organization with proof of having demonstrated academic leadership **OR**
 - ten years of experience at an equivalent level in industry or organization, in skilling/vocational education or training

Salary and Service Conditions:

- The Pay of Director General shall be fixed at Rs. 2,10,000/- (Fixed) with the existing special allowance of Rs. 5000/- per month.
- The term of office of the Director General shall be determined by the Board for a period not exceeding three years. He/she shall be eligible for reappointment for one more term not exceeding three years.

- The terms and conditions of the services will be those as set forth in the Act, Regulations and manuals of the University.

Procedure for appointment:

- Appointment will be made from a panel of names recommended by a Search Committee constituted under the provisions of KSU Act, 2021.
- UGC as well as State Government Rules, as amended from time to time will be followed and observed for the appointment and other service-related matters for the Director General, KSU.
- **The interested eligible candidates/applicants can apply for the post as per the format of the Application together with (i) Summary Profile and (ii) No Objection Certificate from Current Employer, with all requisite documents arranged chronologically.**
- Nominations / Applications may be sent in the prescribed format in hard copy by post/courier in an envelope super scribed with “**Application for the post of Director General, KSU**”.
