

No: GHR/2005/50/FAC/2005/2350/M3: In exercise of the powers conferred by section 112 read with sub-section (2) of section 40 B of the Factories Act, 1948 (63 of 1948), the Government of Gujarat hereby makes the following rules further to amend the Gujarat Safety Officers Duties, Qualifications and Conditions of Service Rules, 1983, namely: -

1. These rules may be called the Gujarat Safety Officers Duties, Qualifications and Conditions of Service (Amendment) Rules, 2022"

2. In the Gujarat Safety Officers Duties, Qualifications and Conditions of Service Rules, 1983, in rule 3, in sub-rule (ii), -


(i) in clause (b), after the words "Vallabh Vidhyanagar, Gujarat", the word ",or;" shall be added;



(ii) after clause (b), the following clause shall be inserted, namely:-

“(C) Master degree or Diploma in Industrial Safety obtained from the "Kaushalya" the Skill University, Labour, Skill Development and Employment Department, Government of Gujarat or any other College/ Institution affiliated to the "Kaushalya" the Skill University, Labour, Skill Development and Employment Department, Government of Gujarat.”.
